

Photography Guidelines

- 1. We encouraged reservations for photography sessions at least one week in advance. While we are happy to accept walk-in groups if reservations allow, existing services will not be suspended for groups without a reservation and access to indoor areas may be limited or impossible.
- 2. Photography reservations may be scheduled before regular business hours depending on availability of staff. Please inquire if you are interested.
- 3. Parties taking photography on the premises are not to disturb Mari Vineyards guests *i.e, ask them to move, ask them for assistance with photography, etc.*
- 4. Mari Vineyards will provide a member of our staff to guide photography groups during sessions. The staff member will assist with access to designated areas dependent upon the photography package.
- 5. The Standard and VIP photography fees do not include any food or beverage service. Wine and food are available for pre-purchase, please ask if you are interested.
- 6. Photos may be taken in the vineyard. Do not harvest or touch the grapes. However, access is determined on a day-to-day basis. Access may be confirmed 48 hours in advance by emailing nicole@marivineyards.com.
- 7. Photographers must be able to complete the shoot with their own equipment. Please let us know if you require electric power for any equipment.
- 8. All articles and props brought in for shoot must be removed from premises afterwards. Guests may use certain Mari Vineyards items & property as props only after explicit permission is given. Guests may not touch or move barrels without explicit permission. Guests may not open cave doors or move furnishings without explicit permission. All furnishings must be returned to their original placement.
- 9. Clean-up of all areas is the responsibility of the client.
- 10. Any and all damages or losses to the property will be the responsibility of persons or businesses requesting use of Mari Vineyards. The credit card on file will be charged accordingly if necessary.
- 11. There is no smoking permitted anywhere on Mari Vineyards property.
- 12. No weddings of any kind may be hosted on Mari Vineyards property. Your reservation is for photography only.
- 13. No bottle consumption may take place on Mari Vineyards property. Guests are welcome to purchase glasses, flights, or tastings of wine. Bottles may only be purchased to-go.
- 14. Vehicles may not be driven on any surface other than the paved roads and parking lots.
- 15. We do not have changing facilities, although public restrooms are available in our Tasting Room. Should you book the VIP Photography Package, your reservation will include our private Founders Room space with its own private restroom. Our Wine Caves also feature available restrooms.
- 16. If cancellation occurs due to poor weather, rescheduling is contingent upon availability of the grounds.
- 17. A credit card is required on file to reserve the photography session. At the end of the reservation, the credit card on file will be charged for the full amount. If for any reason a guest/photographer arrives late, photography sessions will still be charged by the hour; no discounts will be given for delays. The card on file will be charged for each hour the photography session is active, and the hour in full will be charged regardless if it is used completely.
- 18. Cancellation Policy: Cancellations made at least 48 hours in advance will not be charged a fee. No-shows or cancellations made less than 48 hours in advance will be charged the full fee for the designated Photography Package for 1 hour's worth of time.



Release of Liability Statement

The undersigned, and all participants involved, hold harmless Mari Vineyards, have read and agree to abide by all of the Winery photography policies, guidelines and rules, and will assume responsibility for any damage done to the properties or their contents during and occurring as a result of using the properties.

Furthermore, the undersigned and all participants involved will participate in the photo shoot on the Mari Vineyards properties at their own risk. Mari Vineyards will not be liable for any damages arising from personal injuries sustained by any such person on the premises of the properties. They certify that they will not hold Mari Vineyards, its agents, employees or associated companies responsible for any harm occurring wholly or partially as a result of any existing health problems. They assume full responsibility for such injuries. Mari Vineyards shall not be liable for any equipment, property or personal belongings of the undersigned and all participants involved.

I, the undersigned, and all participants of the photo shoot understand that our participation and/or involvement in participating in a photo shoot at Mari Vineyards carries with it the potential for certain risks, some of which may not be reasonably foreseeable. I further acknowledge that these risks could cause me, or others around me, harm, including, but not limited to, bodily injury, damage to property, emotional distress, or death.

By signing this agreement, I agree to release, indemnify, and hold harmless Mari Vineyards, as well as all employees, agents, representatives, successors, etc. from all losses, claims, theft, demands, liabilities, causes of action, or expenses, known or unknown, arising out of my participation.
